1st **Tirana Gas Pipelines Safety Workshop** "Safety: choice or necessity? Technical, economic & cultural approach"

Dear Ambassador, distinctive guests and participants,

It is my pleasure to be here today and hold a speech regarding TAP project, its importance for our country, for the region and even more, as well as for the importance of the safety in the simple and complex meaning of the word considering the strategic importance of the investment in figures and in effects too.

This project has been always considered and estimated as an important benefit for Albania in some points of view:

- 1. Image building Albania institutionally, politically and economically becomes important integral part of an international network, or community better defining it, in terms of economic collaboration, common institutional decision making, international and regional policy making, designing and projection, as well as technically and standards related collaboration and implementation in an international and regional level. In this regard, our contribution has been as important as all other partners' ones.
- 2. Image improvement related to the foreign direct investments climate in Albania, increasing attractiveness to other and more investments.
- 3. Regional strategic role increased of Albania due to the possible regional integration of TAP as possibility for the other Balkan countries too. I can mention here the importance TAP has in the future new project IAP since the very first stages to the completion of this project.
- 4. Impact TAP has had in acceleration of processes related the regulatory package for the gas sector, to the unbundling of Albpetrol and to the future development of gas market in Albania.
